#### The BIG Giggle Rules:

2. A maximum of 15,000 raffle tickets will be sold. Chances of winning depend on the total number of qualified entries.
3. Prizes will be awarded by random drawing of all sold raffle tickets.
4. Winning raffle tickets will be drawn at Riverside Park on Saturday, July 4, 2009 at approximately 6:30 pm. Entrants do not need to be present to win. Winners may be asked to prove identity. Winners who are not present will be notified by mail or telephone. Prizes must be claimed within 30 days of notification of winning.
5. A list of winners may be obtained by sending such a request in writing along with a self-addressed, stamped envelope to Children's Museum of La Crosse, 207 5th Avenue South, La Crosse, WI 54601.
6. Presenter reserves the right to substitute prizes of comparable value.
7. The charitable fundraising purpose of this event is defeated if free entries are allowed. However, one free entry per household can be obtained by presenting a written request, along with a self-addressed, stamped envelope, to the address listed in Rule #5 between 11:00 am and 4:00 pm Tuesdays through Fridays, April 1, 2009 through July 2, 2009.

An official raffle ticket or order form must be completely filled out and delivered to Presenter or authorized representative of Presenter or mailed to Presenter at the address in Rule #5 and must be actually received by Presenter no later than 5:00 pm on July 4, 2009 to be eligible for the drawing.
