# The Children's Museum of La Crosse offers a variety of discount options for group visits:

- Informal groups:** If your group of 10 or more people visits during regular hours without pre-registration, you may request the group discount of \$1.00 off per person (no free adults/staff).
- 10 or more kids:** With pre-registration, groups of 10 or more children can visit the Museum as a field trip for \$5.00 per child with FREE adult chaperones. Early admission and interactive presentations may be available at no extra charge during the school year. *See field trip brochure or funfieldtrip.org for details. Must call ahead to schedule.*
- Special groups/Child Care providers with less than 10 kids:** Eligible non-profit organizations which serve low-income or special needs populations OR licensed child care centers with less than 10 youth/clients per visit can pre-purchase admission for youth/clients (and use until the balance is depleted (additional \$ can be added at any time). No cost for adult chaperones/staff. Visits do not need to be scheduled.



- 12 admissions = \$72** (\$6.00 per client/child, adult chaperones/staff free)
- 25 admissions = \$125** (\$5.00 per client/child, adult chaperones/staff free)
- 50 admissions = \$200** (\$4.00 per client/child, adult chaperones/staff free)
- 100 admissions = \$350** (\$3.50 per client/child, adult chaperones/staff free)
- 200 admissions = \$600** (\$3.00 per client/child, adult chaperones/staff free)

## IMPORTANT NOTES:

- 1 adult (age 16+) required per five children
- Adults must supervise children at all times
- Child care centers must include copy of license documentation
- No food or beverage allowed unless lunch room is rented for \$35.00
- Coupons/other discounts cannot be combined with these offers
- For visits of 10+ youth/clients, schedule a field trip in advance
- Organization is responsible for checking and reloading balance as needed. Youth/clients will not be admitted if balance (# of covered admissions) on account is depleted.
